








Vietnam Domestic E&P map

Exploration




- •Until the end of 2008, PVN has signed 64 petroleum contracts with 41 still in forces (in form of Petroleum Sharing Contracts, Business Co-operation Contracts, Joint Operation Contracts and Joint Venture).
- •~443,000 km 2D seismic (38,640 km in 2008) and ~49,000 km² of 3D acquired (10,890 km² in 2008).
- •54 well drilled in 2008 (13 exploration, 14 appraisal and 27 production).
- Total hydrocarbon reserves of Vietnam increased 50 million tons of oil equivalent.
- •One licensing round (NCS bid) for 7 blocks: 03, 04-1, 04-2, 19, 20, 21, 22-03 successfully opened by Petrovietnam and more than 20 international oil and gas companies participating in this licensing round.
- 04 new petroleum contracts were signed after that .





Under operation:

- Rang Dong Bach Ho Phu My Gas Pipeline System (capacity: 2 billion m3/year).
- Nam Con Son Gas Pipeline (capacity: 7 billion m3/year).
- PM3-CAA Gas Pipeline (capacity: 2 billion m3/year).

In preparation stage:

- Block B & 52B O Mon Gas Pipeline (capacity: 6 billion m3/year).
- NCS (Block 05.2, 05.3): second pipeline.







- Ba Ria Power Station: 350 MW (EVN).
- Phu My Power Plants: 3500 MW (EVN, BP).
- Ca Mau 1 Power Station: 750 MW (PVN).
- Ca Mau 2 Power Station: 750 MW (PVN).
- Nhon Trach 1 Power Station: 450 MW (PVN).
- Nhon Trach 2 Power Station: 450 MW (JSC).
- Hiep Phuoc Power Plant: 375 MW (BOT).

Gas fired plants supply 40% total electricity of Vietnam





DOWNSTREAM ACTIVITIES (REFINING/PETROCHEMICAL)







- Dung Quat Refinery (Ref. No.1), under active implementation, estimated put into operation in the end of 2009 (PVN 100%, EPC, Contractor: Technip).
- Nghi Son Refinery/Petrochemical Complex (Ref. No. 2): J/V signed 07 Apr 2008 (PVN, KPI, Idemitsu Kosan, Mitsui Chemical)
- Southern Refinery (Ref. No. 3): Under study stage. (Joint venture will be selected)



Refineries and Petrochemical Projects Location







PETROCHEMICAL PROJECTS Fertilizer Plants





- Phu My Fertilizer Plant:
 - -Capacity: 740.000 tons of Urea/year; (30% Domestic Demand).
 - -Operation since September 2004.
- Camau Fertilizer Plant :
 - -Capacity 800,000 tons of Urea/year.
 - -EPC contract signed 06 May 2008.
- Southern Petrochemical Complex (PVN, Vinachem, TPC, VSCG Chem): J/V signed 13 March 2008 (operation expected 2011).

Fiscal regimes

- The Government of Vietnam and Petrovietnam are continuously improving the petroleum contract's terms and incentive conditions to attract more investment.
- Forms of Cooperation: PSC, JOC, BCC, JV....
- PSC (Production Sharing Contract) selected as the basic frame for petroleum contract
 - Flexibility
 - Competitiveness
- JOC (Joint Operating Company) is an extended type of a PSC, applied for most prospective blocks/areas
 - JOC will be the Operator
 - All parties shall participate in operatorship
- Forms of E&P project bidding : International Competitive Bidding & Direct Negotiation.

Forms of E&P project bidding

Competitive Bidding:


- > In compliance with PV exploration plan.
- Time frame: Set by PetroVietnam
 - Licensing Round:
 - Widely announced
 - Usually for large area(s) covering many blocks
 - Limited Bidding:
 - Invitation sent to limited number of qualified companies
 - Usually for a single block/acreage.

Direct Negotiation:

- In special case, when open block is not yet included in competitive bidding plan and there is only one company interested in.
- Time frame: any time
